APPLICATION FOR CONCESSION SPACE - FALL FAIR

This rental agreement between the Albion & Bolton Agricultural Society and the party named below hereinafter called the lessee for the 2011 Agricultural Fall Fair, September 23, 24 and 25, 2011.

Outdoor space will be \$17.00 (tax included) per foot frontage, minimum of 10-foot frontage. Hydro (limited space) is \$30.00 extra. (Please note hydro will be limited to a single 15amp connection; multiple outlets will be charged additional \$30.00 per connection, including power bars). All fees must be prepaid by September 1, 2011. Each booth will be issued two Concession Space passes for the weekend.

Vendors are responsible for supplying their own display tables, chairs and accessories. Vendors requiring power will need to bring sufficient power cords. The vendor area will be open Friday morning from 9:00 a.m. to 5 p.m. for setting up displays. Vendors will be assigned a designated spot. If requesting an outside space vendors will use their own discretion to bring their own tents

The hours that the lessee will be open for business during the fair are:

Friday, September 23, 2011	06:00 p.m. – 10:30 p.m.
Saturday, September 24, 2011	09:00 a.m. – 10:30 p.m.
Sunday, September 25, 2011	08:00 a.m. -- 4:30 p.m.

All lessees must be set up and ready for business by 6:00 p.m. Friday afternoon.

All lessees must comply with all Local Health Requirements.

All lessees using Propane must complete the attached form to comply with the Provincial Propane regulations.

All lessees must carry their own liability and loss of property insurance - minimum one million dollars. Proof of insurance to be provided with fee payment.

HOLD HARMLESS AGREEMENT:

I the lessee, shall indemnify and HOLD HARMLESS the Albion and Bolton Agricultural Society, their members, agents and employees from and against all claims, demands, losses, costs, damages, actions suits or proceedings by any third parties that may arise out of, or may attribute to all operations performed by or carried out by the lessee, his agents employees, or servants, or anyone for whose acts he may be held liable, howsoever caused.
